Noble Mineral Exploration Partners with ORIX Geoscience Inc on Project 81

Toronto, Ontario – September 18, 2017 Noble Mineral Exploration Inc. ("Noble" or the "Company") (TSX-V:NOB, FRANKFURT: NB7, OTC.PK:NLPXF) is pleased to announce that the company has partnered with ORIX Geoscience Inc. ("Orix") to compile a complete, extensive, comprehensive and detailed data compilation for its very prospective Project 81 Property, located north of Timmins and immediately adjacent to the Kidd Creek Mine.
