## **Noble Receives Final Approval of its Private Placement**

**Toronto, Ontario – September 21, 2017 – Noble Mineral Exploration Inc.** ("Noble" or the "Company") (TSX-V: NOB, FRANKFURT: NB7, OTC.PK:NLPXF) is pleased to announce that the financing (the "**Private Placement**") it announced on August 25, 2017 has received the final approval of the TSX Venture Exchange. As previously announced (see the Company's news releases of September 1 and 7, 2017), Noble raised in the two tranches of the Private Placement aggregate gross proceeds of \$1,199,999.7 through the issuance of 19,999,995 common share units and \$750,000 through the issuance of 10,000,000 flow-through units.

In the two tranches of the Private Placement, Noble paid a total of \$107,819.98 as cash commission, and issued 746,666 broker warrants exercisable for common share units at \$0.06 per unit, and 1,000,000 broker warrants exercisable for common share units at \$0.075 per unit. All broker warrants are exercisable for 5 years.

Each common share unit in this Private Placement (or upon exercise of broker warrants) is comprised of one common share and one warrant exercisable at \$0.10 per common share for 5 years. Each flow-through unit is comprised of one flow-through common share and one warrant exercisable at \$0.10 per common share for 5 years.

The securities issued in the Private Placement are subject to a hold period of four months and one day.

Noble will use the proceeds of the Private Placement to continue its exploration activities, to pay debts and for general working capital purposes.

Noble Mineral Exploration Inc. is a Canadian based junior exploration company which, apart from its shareholdings in MacDonald Mines Exploration Ltd. and its interest in the Holdsworth gold exploration property in the area of Wawa, Ontario, holds in excess of 70,641 hectares of mineral rights in the Timmins - Cochrane areas of Northern Ontario known as Project 81.
